# YOUR RIGHTS YOUR RIDE.



Monday morning a week ago, we woke up to a inch and a half of ice covered by 5 inches of snow. Today we still have snow in the shade and are expecting 75 degrees tomorrow. Our weather is like our politics; you hope for the best, expect the worst and keep your eye out for sunshine.

Our Motorcycle Helmet Reciprocity Bill, HB1676/ SB1846, had the best of hope, not to mention plenty of support by legislators. The worst came, as expected, when the Governor called out the dogs and went to work on trying to kill a bill with a zero fiscal note and no negative impact on the state. Keep in mind that the state prepares the fiscal note. Col. Trott of the THP claims they couldn't enforce this and would have to stop every motorcycle that crossed the state line. He must have forgotten the fact that the THP and most other law enforcement in Tennessee have and use Automatic Tag Recognition. This gives them the capability to read tags from several hundred yards and automatically runs it through a national data base while the patrol car is in motion. Forgetfulness does come with age as I well know myself.

As usual with any bill we submit, TennCare had to weigh in. Even though according to the State's own calculations that this would not cost Tennessee anything, TennCare claims that it would. I reckon a fiscal note only has value when it stops any attempt at adult freedom of choice. It does make things difficult on trying to get legislation passed when they seem to be able to change the rules at will.

Needless to say the dogs growled at our supporters and the next thing you know folks get a might weak in the backbone. This all seems bad enough, but it got even worse. We, CMT/ABATE, Inc., sealed the fate of our own bill. We are all adults and know how to act in a court room, a church house or in this case, the House Transportation Sub-Committee hearing room. So much for all of us knowing how to act in public. We had a member called down not one, not two, but

three times within a 5 minute period. Next thing you know the Reciprocity bill is sent to the black hole of Summer Study. Hold on it gets even worse. After we left the hearing room someone in our group had to say something derogatory towards the Chairman of the House Transportation Committee. The only thing missing from this little adventure was some fool hollering out "Hey,yall watch this!"

Your lobby team and volunteer fire department have been on the job putting trying to get the flames under control. Due to the aforementioned fiasco, it was in our best interest to take HB1967/SB2161, the Safety and Emissions Compliance Bill, off notice. We can bring it back and will.

Don't let all this get you down. We were able to accomplish something worthwhile by honoring Deputy Commissioner and Chief Engineer Paul Deggs of TDOT with a Champions award. Even though he isn't involved in legislation, his efforts to build more motorcycle friendly roads in Tennessee truly have earned him this award. 




The last few months MRF has kept you warm and toasty, maybe even down right on fire, with information on ethanol, checkpoints, and the fact that according to the CDC we are a plague on society. Just our way of fighting the winter chill. We just can't let you down and are looking forward to making summer a real scorcher.

In 2015 all vehicles will be required to have "Event Data Recorders" more commonly known as a black box. Some insurance companies have offered discounts for voluntary use of these devices for a while now. The problem arises with how the information collected is used and by whom. How would you feel if you were sent a speeding ticket after having an inspection done on your bike? Most of us sane folks know that this information should not be admitted as evidence in any type of legal matter. In fact, the black boxes should not be mandatory on any vehicle in the first place. It's just another invasion of privacy by Big Brother. Some states are attempting legislative action

to prevent misuse of the data by law enforcement and we are keeping an eye on their progress. This may be an issue for Tennessee very soon. For now we would like to ask you for a little help. How many of you have a motorcycle with a black box, and what year model and brand is it? We would appreciate any input you can provide.

Discrimination of motorcyclists by insurance companies is another matter we are watching. We would still like any information you may have on claim or policy denials due to the fact you were on a motorcycle. An actual letter of denial would be perfect. I have heard second hand reports of this happening, but as of yet I haven't received any information from someone that has actually had this happen.

Watch for the MRF banner at local events and drop in on us. We will have some drawings for folks making donations to MRF and for those that become members. Help US keep YOU on the road.




-We reviewed some NCOM Newsbytes and passed around some papers for members to read.
