

This has been an amazing election season for Tennessee. But moreover, motorcyclist's activism in constituency has surpassed any thing I've witnessed in the past ten years.

Huge kudos go out to our Regional Legislative Coordinators Tony Dabbs, Johann Forbes, Angel Richardson and Scott McColpin! They jumped in and remained right at the pulse of our election campaign needs.

More big kudos for an awesome first ever helmet choice parade in support of our candidates. Kim Marlin and her Smith-Wilson Charter, Terry Presley and his Caney Fork Charter and Teresa and Denny Hemphill and the Stone's River Charter made it an awesome and very repeatable event! Kim whipped this thing together in less than ten days including parade permit and police escorted parade!

Amazing things have been happening across the state. So many motorcyclists made their activism known to candidates. We know of at least a dozen incumbents and new candidates who were aware of our pro-active election voice that helped them retain or gain office.

Here is a quick picture of the campaign results: Eighteen out of 24 House Helmet Liberty bill Sponsors are returning to office. We only lost four sponsors: 2 retired and 2 defeated in primaries. The other two moved up to successfully obtain their bid for a Senate seat.

That leaves six freshman House Reps assuming seats of our former sponsors. They will receive our first priority for sponsorship so that we can return to our highest number in cosponsors from last year.

There are 16 more "freshmen" or newly elected House Representatives to approach for co-sponsorship as well. That equals a total of 50 potential co-sponsors. We were also a proactive force in long term House Reps who enjoyed support from motorcyclists.

I think the biggest thing to mention is that the GOP party has now obtained what is called a super majority. The reason why I bring this to mention is not for party allegiance. Our bill enjoys support from both parties and CMT/ABATE is a non-partisan organization.

I only mention this because we have been told for more than a decade that if only the GOP could gain control over the House, we would enjoy our liberty restored. Well, they've had it for two years now and it's time to stop dancing and start courting for the real thing.

By vote of the September Board of Directors, you will have TWO registered lobbyists working for your benefit at the Capitol. We will be registering my best partner and amazing thinker Tony Dabbs.

The activism we participated in this year for election campaigns, the fact that we know of at least a dozen legislators who can honestly say "motorcyclists helped my election" and now with two registered lobbyists, CMT/ABATE has become a strong political ally at the Capitol. We are going to respectfully take the super majority to task and expect that our bill is something they strongly wish to co-sponsor.

But your work is not over. If we are to enjoy the liberty that Michigan restored just seven months ago, we still need to be that ever present friendly, voting constituent.

Your next task is simple. Please take the extra minute to send a 'congratulations' card to your House Rep and Senator. Believe it or not, this will mean a whole lot to them to hear from a constituent without a gripe or concern. Just a blank card with a hand note written inside saying you are glad to see them in office to represent your needs in your district.

Don't even bring up the helmet liberty bill. Just a no-strings-attached congratulations.

There is an important reason for this request and it's a simple philosophy in any sales scenario. We are "selling" helmet liberty.

In sales it is labeled a "warm call". A cold call is when the salesman unexpectedly calls or knocks at the door. A call becomes warm when someone has previously made the initial contact with the individual.

When Tony and I are at the Capitol and wish to gain an appointment with a member, your congratulations card makes that appointment move from cold to warm. Representatives are supposed to work for the will of their people rather than a slick sales pitch lobbyist.

Just this year, one Representative told us he would support the bill if his constituents asked him but until then, he could not sign on. He knew he would get calls from the sweet blue haired ladies worried about their motorcycle grandkids and needed to be able to honestly say that his constituents asked him to support it.

With all this said, December 8th is our Legislative Retreat where as a Committee we decide on our legislative agenda for the next session to begin in January. Every member of this organization is a member of our Legislative Committee and owns a vote in this decision process. It is up to you to attend in order to enjoy this contribution.

But every charter MUST have a representative present for this meeting. If that means that your treasury needs to pitch in the cost for their travel, so be it. This IS what we are: a grass roots political activist organization aimed at protecting & improving our form of transportation. Your charter budgets should include this event as the first priority ahead of any event or party.

Every member attending this retreat has a vote. We need you there to help designate your areas of influence in the House and Senate. We will also be discussing Right of Way Violations, mandated rider education for under 18 rider endorsement and federal issues as well.

This is the one and only time of the year that you can have a direct say-so on how this organization proceeds with legislation. Your input is not only valuable, it is necessary. Plus we'll serve ya lunch!

We have specifically scheduled this retreat to happen the day before the December Board meeting in hopes to help facilitate attendance from each char-

ter. Please RSVP so that we have enough food available for everyone.






Did you know?

The National Transportation Safety Board (NTSB) released there 2013 "Top Ten Most Wanted List" Wednesday, November 14th 2012 reports the Motorcycle Riders Foundation (MRF). The list is a collection of the NTSB's top safety priorities. Recommendations are made to governing bodies and industry. Typically the list reflects recent concerns of the NTSB, for instance in a year where there are a lot if motor coach crashes you could expect to see some recommendations to governing bodies to screen drivers better and to industry to make the buses safer.

Most recently motorcyclists made an appearance on the list. In 2010 the NTSB took aim at motorcyclist safety and recommended that each and every State institute a mandatory State helmet law. Its important to note that the NTSB's recommendations are put into place 96% of the time. The MRF met with the staff and Members of the Safety Board aggressively over the following year to educate them on a comprehensive approach to motorcyclist safety. It worked, the following two years ('11, '12) the motorcyclist safety portion of the "Top Ten" was two fold. They recommended volunteer helmet use and just as importantly to them, a strong emphasis on crash prevention.

This coming years list does not contain any motorcycle or motorcyclist recommendations what so ever. They have recognized the work that is being done at the National, State and Local levels is working. Motorcycle fatalities are still less than they were four years ago. They recognize the fact that proper education and awareness programs work. The NTSB realize they have more pressing issues that they need to focus on and that the motorcyclist safety is in good hands, the right hands, the motorcyclists of Americas hands. NTSB Chairman Deborah Hersman "Safety areas are dropped from the list when meaningful progress has been made."

The NTSB is an independent government agency charged with determining the probable cause of transportation accidents and promoting transportation safety, and assisting victims of transportation accidents and their families. Formed by Congress in 1926 their original charter was to investigate only airline and airplane accidents. In 1967 that charter was expanded to include; marine, pipeline, railroad and highway modes.


