Kim Marlin was elected as our new Corporate Membership Director and we are already seeing some great work by her as she wasted no time getting into this job. I recently had breakfast with Kim and the Smith/Wilson/Stones River Local Charter crew before we went to Scooter's Spring Thaw to work with the Don't Ride Fried Carnival. This was all a preparation for us presenting the Carnival to the legislators and staff on Wednesday 22, March 2017 and I think it will be flawless.

YOUR RIGHTS YOUR RIDE



Sitting here in the dark fighting what appears to be another round of pneumonia really puts the 2017 legislative session into proper perspective. The voters of Tennessee have repeatedly told our legislators that we do not want a gas tax increase. Why then do we have so many different versions of a gas tax bill still taking up valuable time on the hill? Why have committees taken the time to bend the rules to permit these bills to live? Why are they even considering voting on a bill that doesn't have any final language prior to amendments? Damned if this doesn't sound just like the same BS our country put up with from the last fool in the White House. I reckon I have been mistaken about Tennessee having a Republican majority. I have been with the party 40 year and the governor is not representing the Values of the GOP. I will admit a reasonable increase in the gas tax would not be a bad thing. Say a half percent to no more than one and a half. Food should never have been taxed in the first place and why do big companies deserve a tax break when the administration wants to burden workers even more?

If a fuel tax is passed after the majority of Tennesseans have said they do not want another tax, we need to consider replacing all the fuel tax supporters during the next election cycle. Their sole job is to carry out the wishes of the people of Tennessee, not the

Governor or businesses.

Years ago I owned a garage and gas station. The increase in taxes would have benefited me in one way. I paid my sales taxes quarterly, so this would have given me an increase in cash flow for a three month stretch. Using others money for three months interest free poses some interesting possibilities. Just think if I had owned a national chain of gas stations. Kind of makes me wonder what's really fueling the drive to pass a fuel tax increase.

All this sounds like I am mad, well, I am. We have had bills dealing with our constitutional rights that have gone ignored because of all this foolishness. In the first place there should never have to be legislation concerning any constitutional right. All rights have already been set in stone and require no further changes. I suggest reading the Constitution of the United States along with the Bill of Rights. This is the supreme law of the land and was not meant to be interpreted to have a different meaning by any judge.

Well, I feel a tad better now. Back to the session at hand. We are watching and have offered to help with three bills this year. The following is a list of those bills and their current status.

HB0002/SB0465, Tillman Goins/Mike Bell: Taken off notice March 1; would permit motorcycles to use shoulders of certain roads to

get to the nearest exit when traffic is moving 25 mph or less.

HB0019/SB0465, Joe Pitts/ Mark Green: To be heard in Senate Transportation and Safety committee on March 20; would permit a motorcycle dealer to apply for a permit to sell bikes one time a year at a different location, provided a 1000 foot buffer zone is maintained with existing shops.

HB0421/SB0316, Martin Daniel/ Todd Gardenhire: Will be heard in House Civil Justice Sub-Committee March 15; would establish a new procedure for asset forfeiture in a criminal related activity.

Now for the helmet law modification bill. We have a caption bill in place to use once we can garner more support in **Memphis** and **Nashville**. We are at the same scenario we faced last session and need yes votes from the same legislators. In order to get those votes, they need to hear from constituents in support of adult freedom of choice. We do not have a definite answer from folks in those areas at this time, so we have had to make a tough call and will not be running a helmet law modification bill this session. Our hands are tied when constituents won't step up.

This will be my last posting as Legislative Director. Johann was elected at the last BOD as my replacement. I will be the new Corporate Director. I will continue to be involved in legislative issues, but you will be spared reading my monthly rants. I have been asked by a few readers to move "Your Rights Your Ride" to an internet site. I will be looking into that for those that want to read the ramblings of an old biker. It has been an honor to serve as the Legislative Director.

A Message from MRF President, Kirk "Hardtail" Willard - **CALL TO ACTION**
February 20, 2017

As many of you know, last year the MRF assumed a new endeavor related to the unconstitutional practice of motorcycle profiling. After reports began to rise from our own membership citing instances where they felt singled out by law enforcement simply because of their appearance, apparel, or because they are simply riding a motorcycle, the MRF decided to take action.

Working with its partners within the Anti-Profiling Action Group, the MRF developed a strategy at the national level to help combat profiling, an issue that affects ALL riders and is unfortunately increasing. We know this to be true because of a survey put forth by the Motorcycle Profiling Project. In 2015, the survey found over 50% of riders across the U.S. reported being unjustifiably stopped by

police at least once while riding their motorcycles. With a participation level of over 5,000 motorcyclists nation-wide, these facts and figures will help support and solidify our concerns over this issue when addressing lawmakers in Washington, D.C.

This year, the Motorcycle Profiling Project has launched another survey designed to reach an even broader audience. Like the previous survey, its results will be used as critical tools in the efforts to obtain legislative relief across the country.

MRF State Rep Report –

I'm running late in writing this, so I'll get right to the point . . .

At the CMT/ABATE board meeting, we discussed a survey being conducted by the Motorcycle Profiling Project. There has been an increasing concern across the country regarding the profiling of people based on riding a motorcycle, or simply dressing like a motorcyclist. This has occurred in a few very visible and well publicized instances, but more frequently it can happen in our daily riding. Most of these incidents are never reported, but we hear plenty of rumors of them.

This survey is being conducted to get those rumors put down on paper so we can use that information to better understand the issue, and develop a plan to resolve it. To quote the MPP web-site, the survey "is intended to more accurately define profiling trends so resources and attention can be focused on the areas that need it the most. As the movement to end motorcycle profiling continues to gain momentum, statistical data and demographic information are an important tool in the efforts to obtain legislative relief across the country".

In other news from the Board meeting, congratulations to Tony Dabbs, who was elected as our new Corporate Director. Tony's long history with CMT/ABATE, and his experience as our Legislative Director make him a great choice for the position.

Also, congratulations to all the members of CMT/ABATE that worked on getting our "Respect Bill" passed in 2015. That effort was recognized by the Motorcycle Riders Foundation, and CMT/ABATE was presented with an award for those efforts.

May 23rd – Bikers Inside the Beltway – This is our lobby day in Washington DC, and an opportunity to bring our concerns and opinions to our US Representatives and Senators.

September 21-24 – Meeting of the Minds – The national conference for motorcyclists' rights organizations, members, and politically motivated motorcyclists. A very full few days of educational sessions, recognition of efforts in the various states, networking with our fellow motorcycling activists throughout the USA, and camaraderie with friends – many that you just met.

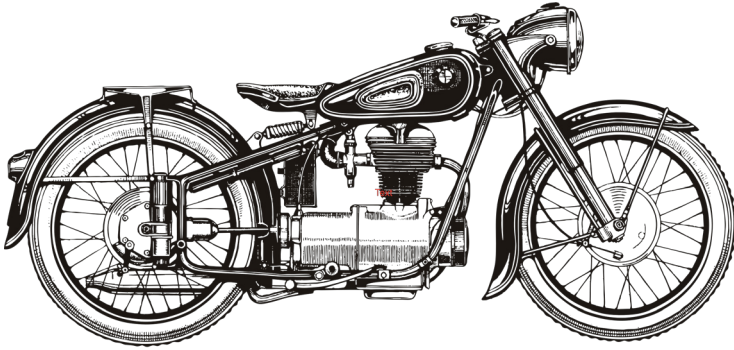
