


Director's Column



Legislative Director's Ramblings

Howdy everyone –We, CMT/ABATE, Incorporated are an advocacy group for Tennessee motorbike riders since our initial founding and our mission remains that we work as a team for the rights, safety, and freedom of Tennessee motorbike riders. Faces and names may have changed – the core mission remains the same.

The 2019 legislative session is half over. While I saw no "texting while driving" Bills that seemed worth our effort of support, a Bill was passed to make it a misdemeanor offense to use a hand-held device while operating a motor vehicle on Tennessee's public roads. The key words are "hand-held" meaning of course that is one chooses to use such an item he must do so hands-free. I predict a small spike for the sale of headsets for those who can't resist yacking and driving a 3,000-pound motorbike destroyer. There will be"immunity from prosecution" for someone who is calling "911" while operating a motor vehicle, as well certain emergency/safety personnel.

Yet - it's already illegal here to text and drive – check. It's already illegal here to

use a hand-held device while in a school zone – check. One can be cited for careless driving - check. One can be cited for distracted driving – check. One can be cited for failure to control an automobile – check. One can be cited for willful endangerment – check. I could go on and on with this since it seems we have a plethora of TCA and city ordinances to deal with the matter. Many of the statute topics I mention require law enforcement personnel to make a judgement call, you know, use their common sense to assess a situation and this new Bill take that completely out of their hands. Kind of a zero tolerance initiative, if you will.

I know that several motorbike riders and other people support this Bill. Personally, I did not like it since it kept dodging the major issue of texting while driving, and automatically makes a criminal out of anyone – even people who practice good discipline – if they use a hand-held device in its normal intended fashion. The devices are not the problem, of course. It's the actions by some who use these devices. Hmm...that sounds familiar. Will it be enforced? We'll see. In short; every-



one will be punished for the negligence to extreme negligence of a few people. Unlike most Bills that once passed and signed become law on 01, July each year, this Bill if signed will become law on 01, January 2020. You know how I feel about this matter, but I do want our highways to be safer for us and all users. Time will tell how well it works.

Reading the news from other SMRO's around our area I don't have a lot of really good news to share. Fortunately, I do not have much bad news to share, but I will share this item of concern. Even in States where the freedom of choice enjoyed a victory a few years ago the quantity of active SMRO members continues to decline. Why? I do not know an exact answer. Did the members from the years of struggle and victory just become too comfortable and leave, or did they just become too old and upon their departure were not replaced by a younger group of men and women ready to engage battle? I have a feeling that it is 25% of the former and 75% of the latter but this is just my estimate. So, if I am correct; how do we change this? Very easily – we attract and keep younger members. I know a couple of our Local Charters have made some changes and seem to be accomplishing this feat in small steps. Let's pay attention to and consider the steps they have taken - that's all that I ask.

I am closing with the same thought as I did last month. I encourage all of the Local Charters to step up their revenue events to build our Treasury. We must cover the operating costs of our Organization 100%, and any 2020 legislative efforts will require even more funding.

Current issues in Washington DC:

On May 1st, the leaders of the House Motorcycle Caucus introduced House Resolution 338, declaring May 2019 Motorcycle Safety Awareness Month. The resolution sponsored by Congressman Michael Burgess (R-TX) and Tim Walberg (R-MI) reads in part:

"Resolved, That the House of Representatives--

 (1) supports the designation of Motorcycle Safety Awareness Month;
 (2) recognizes the contribution of motor-

cycles to the transportation mix;(3) encourages motorcycle awareness by all road users;

(4) recognizes that motorcyclists have a right to the road and that all motorists should safely share the roadways;
(5) encourages rider education and training for safe motorcycle operation; and
(6) supports the goals of Motorcycle Safety Awareness Month."

Congressman Tim Walberg (R-MI) stated: "Motorcycle Safety Awareness Month is an important opportunity to remind car and truck drivers to always be on the lookout for a nearby motorcycle."

For the first time in over a decade, the

House of Representatives has introduced a measure recognizing motorcycles in the month of May, and we hope it helps foster continued positive conversations about motorcycles on Capitol Hill.

This week the MRF team in Washington met with 24 congressional offices to discuss motorcycle priorities with an emphasis on H. Res 255, the anti-motorcycle profiling resolution. The strategy to get this resolution passed is simple; we need to get as many co-sponsors added to the resolution as possible. A large number of co-sponsors demonstrate support for the resolution and helps let Congressional leaders know that there is broad political support for passing the resolution.

Last year, the House version of this resolution had 39 cosponsors. This year our goal is to get that number above 60. Since the resolution was introduced six weeks ago, we have garnered 22 cosponsors including seven that were added just this week. The letters sent by MRF members and our meetings on Capitol Hill are helping build momentum, but we need to keep the pressure up. The DC team will continue to meet with congressional offices and Bikers Inside the Beltway is a great opportunity for motorcyclists to educate lawmakers about this issue.

We are casting a wide net hoping to gain support from a variety of different states. Our meetings this week were with members of Congress from 21 different states. Currently, Illinois is leading the way with five co-sponsors on the resolution. We will keep you updated on our meetings and the growth of our co-sponsor list.

These two issues, currently working their way through the legislative process, are two parts of the same argument – that we, as motorcyclists, are entitled to equal rights and equal protection. The Motorcycle Safety Awareness Month resolution recognizes that "motorcyclists have a right to the road and that all motorists should safely share the roadways". The motorcycle profiling resolution encourages state law enforcement agencies to treat us the same as any other citizen, and to not use "the fact that a person rides a motorcycle or wears motorcycle related apparel as a factor in deciding to stop and question, take enforcement action, arrest, or search a person or vehicle with or without legal basis under the Constitution of the United States". Your calls to your U.S. Representatives encouraging their support of both of these resolutions will go a long way in ensuring that we can maintain our equal rights and equal protection under the law, and that we can continue to ...


The Department has changed protocols, therefore, the grant is several months later in being approved, but we will receive the funds in time for projects that will involve individual charters and RIDING!!




