Well, we've got four toy runs in November. Unfortunately two are on the same day. I hope to see you there.



YOUR RIGHTS YOUR RIDE




Looking at the calendar I see we have about 15 weeks before the actual 2015 legislative session starts. That's only a little fall riding and some Deer hunting away. Don't forget we also have an election between now and then with some very important issues on the ballot. The proposed amendments to our state constitution could make serious changes to the very foundation of our state law and it is your duty to see to it that the "will of the people" makes the decision on what to change or not. A synopsis of the amendments will be included in this issue of Tennessee Motorcyclist and sent out in email.

September was a little busier than I thought it would be. Just as the issue with the THP and helmet stops was calming down, I was contacted about the verdict in a case in Lawrence County involving a woman texting while driving. The sad part is this driver took the lives of two motorcyclists while she was playing with her cell phone. The judge gave her 4 year probation. If that don't piss you off, nothing will.

I will not mention the names, as I have not contacted the families involved nor do I wish to interfere in any civil litigation that they might pursue.

More than one person has asked what we could do about this and my answer is very simple, nothing. This was a judicial matter where a judge applied the existing law as they saw fit. We are a political advocacy for motorcyclist and deal with legislative issues only. We did our part by strengthening the right of way violation law. We have no say in the application of that law other than by the personal action of our membership taking the time to discuss how this law can be used with their local, judge, district attorney and law enforcement. We have a very good law on the books and one of the strictest in the country for right of way violation.

Another issue that came up was the use of colored lights on motorcycles. We have all seen bikes lit up like Christmas trees with different colors of lights, some flashing some not. Some of these lights are perfectly legal in our state and some will get you a ticket. Carol and I, along with the help of some other folks have researched the light issue and the following information should answer most questions. Bear in mind this is Tennessee only. In some states it is illegal to have anything other than the factory lighting.

SUBJECT: Tennessee Code Annotated § 55-9-302


It has come to our attention that a review of Tennessee Code Annotated § 55-9-302 is needed to address the enforcement of Crash Helmets for motorcyclist. All Enforcement Troopers shall review the statute and better familiarized themselves with the requirements.

In 2006, the State Legislature changed Tennessee Code Annotated § 55-9-302 which permits motorcyclist that are 21 years of age or older to wear helmets that do not have a DOT sticker affixed, however, they must meet one of the exceptions below in TCA 55-9-302 (a), (4). Helmets meeting this standard do not look like a typical motorcycle helmet and will have the exceptions label affixed on the interior of the helmet. Troopers must look inside the helmet to determine whether or not enforcement action should be taken.

Also attached is the Tennessee Attorney Generals Opinion (March 2010) regarding "Cite and Release" provisions. Troopers should take every precaution when detaining anyone for a violation of this or any statute.



Colonel Dereck Stewart of the Tennessee Highway Patrol stating that all troopers will be retrained on the specifics of Tennessee's helmet law and the appropriate way to enforce those laws. Tidwell has promised to stay in touch with Biker's who care and other concerned riders to ensure that these laws are followed and bikers who follow the law are treated fairly. We discussed the right to put your tag on your bike in a vertical position. The law as written today, does provide for this and it is not illegal. A new law will be introduced to allow filtering for motorcycles that is still in discussion. Accidental Death Insurance, you can get for free for being a member has upped to \$3000 for the beneficiary. Meeting of the Minds pledged \$500 for MRF Travel Money for those going \$250.

Activities: November 2nd there is a Chili Run Smith/Wilson Charter; On October 4th Memphis is holding a Fall Bash. We are putting off elections till next meeting. Products from STR raised \$277. 





AUXILIARY LIGHTS ON MOTORCYCLES

THE FOLLOWING INFORMATION WAS SENT THROUGH PR/COMMUNICATIONS TO THE LEGISLATIVE DIRECTOR OF CMT/ABATE FROM THE LEGAL DEPARTMENT OF THE TEN-NESSEE LEGISLATURE. THE INFORMATION IS SPECIFIC TO THE QUESTION: WHAT DECO-RATIVE/AUXILIARY LED LIGHTING IS LEGAL/ILLEGAL ON MOTORCYCLES?

RESPONSE:

In short, *flashing* LED lights, when they are clear or in a *primary* color, are illegal when used anywhere on a motorcycle or other vehicle. There are only certain emergency vehicles permitted by state law to operate flashing lights. Except for blue, red and amber (yellow-orange), state law allows steady *burning* LED lights in all other colors to be used on motorcycles. Below is a Table of colors, patterns and locations of LED lights that **cannot** be used on motorcycles, and I've also included my understanding of relevant statutes below:

ILLEGAL DECORATIVE LED LIGHTS

LOCATION:	PATTERN:	COLOR:
Anywhere on motorcycle	Steady	Blue
Anywhere on motorcycle	Flashing	Blue, Red, White, Amber, Green or Combo
Front	Steady	Red
Front	Steady	Amber
Headlight Assembly/Headlight Grill	Flashing	All colors
Tail Light Lamp	Flashing	All colors
Stoplight area	Flashing	All colors
Factory installed emergency flasher	Flashing	All colors
Backup light area	Flashing	All colors

[NOTE: If a particular light does not fall within one of the above categories, it is legal in Tennessee. For example, it is legal for a person to install a *purple*, steady burning or flashing, LED light bar under the gas tank or under the front or rear fender well.]

Relevant statutes:

T.C.A. § 55-9-402 regulates the types and colors of lights that may be displayed on motor vehicles. [NOTE: The terms "motor vehicle" and "vehicle" in this statute apply to motorcycles pursuant to T.C.A. §§ 55-9-101 and 55-8-101(35).]

Subsection (b) of this statute governs lights placed at the rear of the vehicle. Subdivision (b)(1) requires red lights at the rear of vehicles and prohibits flashing lights of *any color* towards the rear. It states:

"(b)(1) motorcycles and motor-driven cycles shall have at least one (1) red tail lamp and one (1) red stoplight. No nonemergency vehicle shall operate or install emergency flashing light systems such as strobe, wig-wag, or other flashing lights in tail light lamp, stoplight area, or factory installed emergency flasher and backup light area;"

Subsection (d) governs the lights placed at the *front* of the vehicle, and further prohibits *flashing clear, red, or yellow* lights, whether alone or in combination, *anywhere* on a vehicle.

As to clear and yellow-orange ("amber") lights, subdivision (d)(1)(A) states:

"... [N] o vehicle operated in this state shall be equipped with any flashing white or amber lights orany combination of white and amber lights that display to the front of the vehicle."

"As to red and clear ("white") lights, subdivision (d)(1)(B) states:

"No vehicle operated in this state shall be equipped with any flashing red or white light or any combination of red or white

lights that displays to the front of the vehicle."

"As to steady burning red, blue and clear ("white") lights being used together, subdivision (d)(3) states:

"Any vehicle that displays any flashing white or amber lights or white and amber lights, flashing red or red/white lights, <u>or</u> <u>red, white, and **blue**</u> lights in combination, shall be considered in violation of this subsection (d), except for the following vehicles:

(C) Authorized law enforcement vehicles or motor vehicles operated for purposes of emergency equipment companies pursuant to subsection (g), authorized by this section to display <u>red, white, and **blue**</u> lights in combination:

As indicated in Tennessee Attorney General Opinion No. 04-170, subdivision (d)(3) makes it a criminal offense to display blue lights in combination with any *red and white lights*. As noted previously, tail lights must be red. Most headlights are customarily clear ("white"). Therefore, subdivision (d)(3) prohibits steady burning *blue* lights from being displayed anywhere on a vehicle because it would automatically be in combination with the preexisting, red taillights and white headlights.

As to flashing blue lights, T.C.A. § 55-9-414 prohibits these lights from being displayed anywhere on a vehicle, as follows:

"(a)(1) Except as provided in subsections (b)-(f), it is an offense for anyone to install, maintain or exhibit blue flashing emergency lights or blue flashing emergency lights in combination with red flashing emergency lights,"

Finally, the General Assembly has only allowed law enforcement motorcycles that escort a funeral procession to display flashing green lights. Therefore, flashing green LED lights are not authorized on other motorcycles. T.C.A. § 55-8-183(b)(3) states:

"(b) Motorcycle escorts of properly identified funeral processions may:

(3) Notwithstanding § 55-9-402 or any other law to the contrary, install a green strobe flashing light system of a type approved by the sheriff of the county in which the motorcycle is to be operated; provided, that the system is deactivated at all times the motorcycle is not escorting a properly identified funeral procession."

Representative John Tidwell fights for TN riders

Clarksville, Tenn. - *Monday, September 8, 2014* - State Representative John Tidwell has entered into a battle with Tennessee State Troopers that unfairly ticketed motorcyclists while incorrectly citing a law that Tidwell authored.

A group of riders complained to Tidwell about a recent incident in which they were pulled over by a State Trooper for allegedly not wearing Department of Transportation-approved helmets. The Trooper then made the riders wait on the shoulder of the interstate for 45 minutes, while a friend brought the appropriate helmets from Nashville.

Tennessee law does not require a DOT-approved helmet in all cases. For riders over the age of 21 meeting certain requirements, helmets with other certifications may be legal for wear.

Tidwell visited the Clarksville clubhouse of the Bikers Who Care organization on the campaign trail with US congressional candidate Dan Cramer on August 23, in order to get in touch with bikers and learn their experiences on this issue.

"Many bikers I have spoken to have expressed annoyance at the way Troopers have been enforcing the helmet law," Tidwell explained. "As a member of the Transportation Committee, I helped write these laws and I know that the narrow standard that some Troopers have been enforcing is not written in the law. I can understand why someone would be upset about being pulled over for no reason."

Cramer said the helmet law was a hot topic among the riders.

"As we met people and asked them what issues were important to them, the treatment of Veterans and low wages were mentioned quite a bit" said Cramer. "But almost as many people wanted to speak with Tidwell about the helmet law issue."

Tidwell contacted Lt. Col. Dereck Stewart of the Tennessee Department of Safety, Highway Patrol to find out why the law was not being enforced correctly, and also why a State Trooper was imposing a punishment rather than just writing citations. The CMT/ABATE, Inc. (Concerned Motorcyclists of Tennessee/ American Bikers Active Towards Education) legislative team has been instrumental in bringing all interested parties together for the meeting between Tidwell and the Department of Safety. CMT/ABATE, Inc. Legislative Director Tony Dabbs commented: "This law enforcement concern is being addressed properly by all involved. Rep. John Tidwell has been a champion for motorcyclists' rights for over a decade. So far, the 'Education not Legislation'model is working well in this retraining of Troopers' efforts in enforcing the helmet law, TCA 55-9-302.

Tidwell received a letter from Stewart stating that all troopers will be retrained on the specifics of Tennessee's helmet law and the appropriate way to enforce those laws. All State Troopers will be required to read the letter from the chief about the helmet laws.

"I hope this will be the end of this issue, but I will keep in touch with the Bikers Who Care and other riders to make sure bikers who follow the law aren't unfairly targeted," Tidwell said.

Ballot Measures for 2014

There are four proposed amendments to the state constitution that will appear on the ballot for the 2014 election. Your vote on these measures could change the Constitution of the State of Tennessee, thus making this as important, if not more so, than anything else on the ballot.

Amendment 1: This would insert language empowering the legislature to enact, amend or repeal statutes regarding abortion. The legislators, acting on the will of the people could outlaw abortion, place more regulation on it or remove all control. With the current makeup of the House and Senate, odds are that abortion would become illegal in Tennessee. The important thing is to vote and let your representation know what you think on this matter.

Amendment 2: This would empower the governor to appoint judges that are confirmed by the general assembly. According to the Constitution of the State of Tennessee, the qualified voters of the state shall elect judges. The State officials have not followed this process in years and have been involved in lawsuits because of their disregard for our State's constitution. The people of the State should be electing the judges. Do you want the governor and State Legislature selecting judges for you? Do you want to surrender more of your constitutional rights to the state? A yes vote will give more of your rights away.

Amendment 3: This would prohibit the legislature from levying or permitting any tax upon payroll or earned personal income. Simply put, this would outlaw a State income tax. As it should be, you get to decide.


