

YOUR RIGHTS YOUR RIDE



Last month I hoped we would be celebrating a victory or crying in our beer by now. So much for hopes as this roller coaster ride continues in House Finance. Those of you that watched the committee hearing saw HB700 taken off notice. I take the blame for doing that. This prevented us from using a sponsor roll and unlike a roll; being taken of notice has no time parameters. We had the option of putting it back on notice at our discretion. The interesting part is why we had to do this in the first place. The committee chairman runs the show, in this case that would be Charles Sargent. We were to be heard at 3:00pm and were number seven on the calendar. The first move of the chairman is to move a few bills to 5:00pm in order to deal with those relating to the budget. At 5 o'clock we are number 12 on the calendar and it just so happens that there is a reception to honor Gerald McCormick at 5pm. McCormick is a key yes vote and also a leader on the hill. Four of our yes votes are gone to the reception to support their fellow member. This move really didn't surprise us, but it is a good example of what we have to go through in order to

try to get something accomplished.

The newer members of the lobby team are getting a crash course in monkey business on the hill. I do appreciate their hard work and patience. For those that don't know who the members of this lobby team are, here you go: John Ahlers, Shannon "Keebler" Gregory, Wayne Shaub, Gail Strickland, Robert "Johan" Forbus, Rhonda Williams and Tony Thompson. Each one of these folks has contributed to our efforts in their own special way from lobbying the bill to planning strategy. I would like to give Tony Thompson special mention for lending a hand. When was the last time we had a professional lobbyist jump in and help? I don't have room or the memory to name all the folks that have pitched in on HB700/SB925, but we wouldn't still be trying to pass it without each and every one of them.

The lane splitting bill will not move this session, but I do have a plan for continuing this piece of legislation. I will put out more on this later on. We have a lot of work to do in this area and it will be a big part of the next legislative retreat. I am looking at July for the retreat. A date,



time and location will be announced next month. We would like to start hearing from folks that have ideas for potential legislation for the 110th General Assembly. Send in emails, letters or leave a phone message with your thoughts on the matter. This is for everyone and not just CMT/ABATE members.

While I have the opportunity, I want to sing the praises of Ed Domine. Ed replaced me as MRF State Rep and has been doing a fine job of it. He deserves our appreciation and support. Before you know it, Meeting of the Minds will be rolling around and money will be needed to send folks. Be thinking about that when your charter has an event.

I hope we get the helmet law modification bill passed. A lot of hard work and prayer have gone into the effort. Win, lose or draw, we still have to look ahead. I don't know if anyone has plans to take over as Legislative Director, but we will be working on a long term agenda. This will include legislation for the 2017-2018 sessions of the 110th general Assembly and a tentative plan for beyond that. You can never get anywhere without a direction. Right now we are headed in a good direction; we just need to get the whole herd pointed the same way. I would like to leave the legislative business in good shape for the next director, especially a plan they would like to continue. Anytime you have to take a step back, you lose ground.

While we are busy here in Tennessee, it's good to know that someone is watching the chicken coop in Washington. The Motorcycle Riders Foundation is our eyes and ears, as well as our voice, in the nation's capital. Sometimes the issues they are addressing are critical to the future of motorcycling, sometimes they are just providing information for our use, and sometimes they have to chase rather silly issues. like the unsubstantiated rumor described below. I saw this one on the internet vesterday (if it's on the internet, it must be true?) and I assumed it was a false alarm, but it's nice to get that confirmed. I feel a lot better knowing the MRF is watching out for our interests on a daily basis, don't you?

Ed Domine MRF State Rep ed.d@juno.com Report of Motorcycle Curfew Completely False March 13, 2016

A recent report of a supposed curfew enacted by a number of states against motorcyclists has been making the rounds lately, and the Motorcycle Riders Foundation wishes to squelch this nasty little rumor before it gets a life of its own.

It appears that this false story has gained the interest of a lot of people, as many search engines are currently bringing up "motorcycle curfew" as soon as you enter the word motorcycle, it's what the social media experts refer to as "trending".

It pains the MRF to dignify this ridicu-

lous story with a response; however, we appreciate motorcyclists' rights advocates paying attention when things like this come up and want to make sure accurate information is available. To be as clear as possible, there is no curfew being put into effect, and the story is completely false.

The reasons that make the adoption of a curfew by a supposed eleven states absurd are far too numerous to address here, and this complete work of fiction is nothing more than an a bad attempt to either create momentum for some other cause or to serve as a distraction to true freedom fighters.

Keep up the good work, it looks like we've got somebody worried. (Alert issued March 13th,

Dear Members of the Tennessee Legislature,

The legislative team of CMT/ABATE asked me to provide a little information of what has happened in Kentucky since the change in our mandatory helmet law. To give a little background our mandatory helmet law was changed in 1998 to allow for riders over the age of 21 and who had their endorsement for more than a year to choose whether to wear a helmet or not. I was the State President at that time of the Kentucky Motorcycle Association, a sister organization to CMT/ABATE. I am glad to report that overall this has been a boom to our economy on multiple fronts. These include but limited to increases in registrations, licenses, sales and tourism related items.

The first and primary source being that of additional motorcycle shops / dealers and businesses selling related items. One of the newest businesses that have been featured in several trade magazines is a new startup called Gear-Brake. They make an aftermarket safety lighting system for a variety of motorcycles. I personally live in the Northern KY area which has seen the number of motorcycle dealers in the area more than double. Our organization along with Gear-Brake is in the process of a feasibility study with the city of Louisville to create an off-road city park in an area of land that is in a flood zone and cannot be developed under traditional methods.

More evidence that sales are up besides the number of dealers in an area is the state's number of licensed motorcyclists. In 1998 before the change in the mandatory helmet law the state's number was fairly stagnant for several years prior. We averaged around 114,000 licensed motorcyclists at that time. The last set of numbers I just received from our KYDOT Licensing division had the number at almost 177,000 in 2016. Many of these licensed riders own more than one motorcycle so you can see the impact that an increase of over 50% ridership can have to the state directly. The additional sales and property taxes, licensing fees along with insurance taxes and sales taxes to related items such as parts, maintenance items, clothes, etc..


A few examples of increased tourism can be seen in some of the larger biker events here in the state. Until some unrelated legal issues over the name, the former "Little Sturgis Rally" in Sturgis, KY saw an increase in attendance that more than tripled between 1998 and 2008 with one of the largest years having over 50,000 estimated attendees. The All Harley Drags in Bowling Green, KY has had to nearly triple its camping area capacity since 1998 to accommodate the increased attendance. Our own state rally saw attendance increase from around 400-500 to over 1200. This is not to mention increases to event attendance related to Goldwingers riding group events, Harley Owners Group (HOG) events and other riding clubs. For some of these larger events there will be people come from hundreds if not more than a 1000 miles away to attend. Like any other convention group motorcyclists will spend money on hotels, restaurants, souvenirs, fuel and more.

Like most controversial issues there will be some that will try to contradict the positive economic benefits of changing your mandatory helmet statute. Most will center around an increase in deaths and accidents on the highways. Our experience here in KY was that the number of deaths on motorcycles through the 1990s stayed in the mid-80s to low 90s with as I said earlier about 114,000 licensed riders. We did see a spike in the raw number of fatalities up to a high of 110 but at the same time a marked increase in registrations. Here this past year, with our highest number of registrations that I am aware of, we saw the lowest number of deaths, even prior to the change in the helmet law. For 2014 there were 76 and in 2015 there were 80 with about 177,000 licensed riders on the road. We would like to attribute this to a combination of an aggressive Share the Road with KYDOT's Office of Highway Safety and our County Fiscal Courts coupled with a change in our instructional permit process. Previously you could renew the instructional permit every few years an unlimited number of times. We were able to pass legislation limiting this to a total of two years or else taking a qualified rider education course. Getting the general public educated to motorcycles on the roads along with riders trained and licensed properly has helped to drive the number of accidents and fatalities down far more than a helmet law has ever done.

To wrap up, the philosophy we promote is that accidents need to be avoided in the first place. Helmets may help in some cases and hurt in others with injury mitigation. However if the accident is avoided in the first place, there is no reason for mitigation.
