DIRECTORS COLUMN

I've been reading a lot of things recently that really disturb me. A few weeks back I was going through the MRF Reports from the Motorcycle Riders Foundation in Washington DC. There was a whole article about how the Center for Disease Control had issued a statement that the only thing that would save a motorcyclist's life was a nationwide helmet law. Not one word about the benefits of the training courses.

Last week I was at the office and saw an email from MRF. It said the US Government Accountability Office had released a report on the safety grant program. They thought that money should be used for other things besides training, including helmet use campaigns. If helmets really save lives, then why do some mandatory helmet states have higher death rates than some freedom states. I would think if someone was interested in the facts, they would look at the states own figures.

Just yesterday I picked up the Tennessean. Right on the front page it said "Motorcycle Safety Spending Has Its Limits" The article said Tennessee Taxpayers would pay an estimated \$118 million for motorcycle fatalities this year. That sounds ridiculously high to me. The Journal of American Medicine published a study on public costs of motorcycle related injury. The results clearly showed motorcyclist cost no more than any other injury. A similar study by the

University of North Carolina reached the same conclusion.

If someone wants the truth, you can tell them, Helmets do NOT save lives, and motorcyclists are NOT social burdens.

Thank you to all who attended our legislative retreat. Your thoughts and contributions were so spot-on for our needs. We thoroughly addressed out some very important topics and in my opinion, made very intelligent and valuable decisions that day.

For those members who were unable to attend, minutes of the meeting have been provided to every Charter Director, the At-Large Coordinator and every Regional Legislative Coordinator (RLC). They would be more than happy to email you a copy. Or better yet, attend a meeting and you will likely get a hard copy in your hands.

One of the highlights of our meeting was a decision to delay our lobby day this year to the month of March. There is a much greater chance of riding weather and at least another hour before it gets dark. We are going to attempt to have reserved bike parking so please begin your plans to save a sick or vacation day.

Please let every biker you know that we will be having a ride-in Lobby Day next March. Our lobby day is for all motorcyclists and not just CMT/ABATE members.

We also agreed that we should display an info table in the hallway during our Lobby Day. If you are interested in helping to create our info board and would like to help out, please let me know as soon as possible.

As soon as we know what days the Transportation Committees will be scheduled, we will pick a day on the calendar. The announcement will be in the February & March

Newsletter and will go out on the PR/ Communications email list.

This brings up a good point... If you have not sent an email to csfreedom@aol.com to request your email be added to the list, you are missing out on a lot of good information. Carol sends our motorcycle event info as it is brought to her attention.

And with a monthly publication, anything you read is at least 20 days old news. During the legislative session, I provide weekly wrap ups that go out through the email list. My legislative report in the newsletter is usually the 'cliff notes' of what is going on at the Capitol. The meat and potatoes will be in the weekly wrap up.

At the December Board meeting, thirteen more members from seven charters were recognized as our leaders in acts of constituency. These Champions are: Jesse Henne of Montgomery, Becky Gregory of Dickson/Humphries/Hickman, Faith Hawkins of Nashville, Leon Lightburne, Denny & Teresa Hemphill & JC Meeks of Stones River, Kim Marlin, Ruth & Bullit of Smith/Wilson, Trina & Lee of Upper Cumberland and Terry Presley of Caney Fork.

These members have showed outstanding devotion and patriotism in their willful acts to participate in the election campaign process. Those present at the conclusion of the Legislative Retreat had their efforts rewarded by receiving the exclusive Helmet Liberty patch. All will now be eligible to be one of the few chosen for the limited rocker patch that says "Thank Me" when helmet liberty is finally restored.

We have been promised a meeting with the Governor by the Governor. Hopefully that will happen before the busy session starts.

The plan to set our Lobby Day in March will also afford the legislative members some breathing room. All will be buried in the Health Care debacle. So once our day rolls around on the calendar, our smiling faces should be a welcome distraction from a very burdensome subject.

Tony and I are committed to hit the ground running January 8th. We have already been visiting the Capitol to secure our bill sponsors and become more familiar to the 23 newly elected members.

You should know that we have been well received thanks to the many acts of constituency that happened during this election campaign. Over a dozen members know that they are there because motorcyclists helped them and they won't be keeping that a secret among their colleagues. This includes Republicans and Democrats, new and returning members, men and women. We have literally been a presence across the board.

When newly elected Speaker Pro Tem Curtis Johnson of Montgomery County was passing through, I congratulated him and said that there are a lot of bikers back in his home district that will be mighty proud of him. He agreed that his district is full of good bikers.

After a meeting with Liberty Bill prime sponsor Judd Matheny, Tony and I emerged even more confident of a new and radical plan for next year. We asked if he thought we could garner 50 co-sponsors of our Liberty Bill in the House. This would make a simple majority and speak loudly in favor of our bill.

With 24 sponsors last year, we were strongly assured that it was a very attainable goal. How did we get 24 last year? Registered voter motorcyclists asked their Representatives. Now not all who were asked agreed to co-sponsored and some of them are now gone. But not all were asked. This year, every member needs to be asked by a motorcycle constituent to sponsor our bill.

It would not matter how wealthy our grass roots organization is, we cannot purchase the power that proactive motorcycle constituents possess. We could pay the biggest and best lobbyist a healthy salary and that still would not help us restore our liberty. It requires boots on the ground in the district actively pursuing liberty like the cherished American right we so strongly deserve.

This organization has become what its founding members dreamed it to be. As we continue to satisfy that lofty goal, what will you do to help bring us to victory in liberty?

Meeting was held at "Sling Shots" and called to order by Wendell at 2:05pm.




