# LEGISLATIVE UPDATE:

As of 2/21 our bill has been rolled to the next Transportation Sub-committee due to a busy schedule and need for one more favorable vote. We are prepared to present a wealth of information when this bill is called before committee. We will be asking that constituents from the districts of the members on the Committee please come out to meet with their members ahead of schedule and respectfully watch the committee discussions and vote.

We will also be enlisting the aid of out of state motorcyclists to help make a statement as to the financial impact our state is missing out on in members districts who oppose our bill.

If you have not added your email to our email update list to be "in the know" as it happens, please do so immediately. We are sharing information over that format as it happens. We need you to play an integral part in this bill. This is the most valuable 'forward' you can send to your out of state friends to support our bill. We all know the wonderful roads and rides we'd love to take them on if only this state would grant them the respect to decide what they wear when they ride.

So if you want to help positively affect your helmet liberty in Tennessee, get busy and get signed up for our email updates!

The following is an answer I provided to an individual who wrote of his disappointment in our position regarding helmets. He is an avid rider with a professional history in Motorcycle Safety.

I share it because the answers in this correspondence serve as good talking points when you are out and find yourself in mixed company of helmet law supporters...

LETTER TO CONCERNED HELMET PROPONENT RIDER: I am also sorry for your family's loss and suffering on account of a motorcycle accident.

NHTSA reports year after year that the number one cause of motorcycle crash fatalities is blunt force trauma to the torso; more specifically and gruesome, punctured lungs and ruptured aortas from devastating impacts without protection. This organization simply cannot participate in agreeing that helmets are necessary precaution to safe motorcycling without conceding that we must also helmet the heart and lungs – an impossible feat even for full size motor vehicles with seatbelts and airbags.

We have plenty of data that shows helmet use can also cause

death. Dale Earnhardt is a second example of what could have happened when we hear reports of a motorcycle fatality and the reporter concludes with "the rider was wearing a helmet at the time of the crash".

I hope that you appreciate that as an organization we are 'pro' helmet. My husband and I moved here from the liberty state of Indiana with no less than 8 helmets. So I am also 'pro' helmet use.

But the fact remains that this organization is not 'pro' helmet law. The device is sold as an accessory with a warning sticker inside that says it was only tested to a velocity of less than 14 mph. Every year, 50% of those tested FAIL tests administered according to the specified federal criteria. Yet our federal government continues to stand behind the 'safety' of a helmet without the benefit of a consistent standard such as with manufacturer warrantee and installed seatbelts.

To better explain this organizations work for all motorcyclists, let me pose a reversed scenario to you. We have enough data that some law makers could assume it is their responsibility to outlaw the use of helmets while riding a motorcycle in Tennessee. What would you then say to your motorcycle rights lobby organization? "They can't do that. You've got to stop this!!! This is unconstitutional!"

And we would agree with you 110% and fight that tyranny as vehemently as we do this equal injustice. There has to be a line drawn as to how much our government is allowed to play God and that is what this law attempts to do.

One Legislator told me a story of his cousin riding a bike and what happened when it got squirrelly under him. He started to slide sideways and when he was leaning, he cracked a pole with his helmeted head. It knocked him out but he survived the blow only to drown in a puddle 15 feet away. This Legislator thinks we're nuts for wanting this reform but he is convicted that it is not his job to play God.

I hope this enlightens you to our position on this matter. If not, I hope we can choose to disagree and still remain friends of differing opinions.

This organization is so much more than just helmet legislation. We are motorcycle preservation. The safety, quality and assurance to enjoy IS and will remain our top priority.




