

# **YOUR RIGHTS YOUR RIDE**



At the April 19 Nashville Swapmeet, I found myself riding the chair instead of a scooter and fighting a case of food poisoning from a bad burrito, but I still managed to have a good time and promote CMT/ABATE and MRF. We were even able to gain additional legislative input from a survey and hold a short legislative update meeting for those interested. I want to thank everyone involved for the table we had and the help.

A few weeks ago everyone was given the opportunity to voice their thoughts on topics for potential legislation in 2015. I was glad to receive a few emails and phone calls from folks that had something to say. The following is a list of those recommendations.

Bear in mind the two bills we initiated and supported in 2014 (the second year of the 108th General assembly) will need to be re-submitted next year in the 109th General Assembly. Both sponsors, Rep. Keisling for the Compliance Bill HB 1967 and Rep. Tidwell for the Reciprocal Bill HB1676, are eager to work with us again on these issues, providing they are re-elected. Be sure to offer any and all assistance possible in their re-election campaigns.

Each charter and the At-large membership need to go over this list, along with any other ideas that may come to them, so that their representative to the Legislative Retreat on July 26, will know how to vote. This will be the decision making meeting for the 2015 session.

#### Helmet choice for adults, Repeal of the helmet law, Stricter turn signal laws and enforcement, Profiling, Safety, Lane splitting, Shoulder use during an accident on interstates, Cellphone use, Helmet should come with bike, Tougher penalties for Right Of Way violations.

With all this pretty riding weather let's not forget that this is an election year for all state Representatives and part of the Senate. Get to know your candidates and ask the important questions. Find out what their opinions are on motorcycles and the helmet issue. If they have an uneducated viewpoint on these matters, take time to provide them with some facts rather than an argument. The impression you make on those running for office could make all the difference in the world when it comes to our future efforts.

The future of this organization has become a topic of discussion among a lot of the membership. Wayne Shaub, our other registered lobbyist, and I have devoted a little extra time pondering the legislative aspect of that  $_{A}$ 

future. What direction does the organization want to go in? That would appear to be a foolish question concerning an outfit founded on getting the helmet law repealed, but helmets aren't at the top of the totem pole with the younger folks. Therein lies the problem. We are now a bunch of senior citizens that have to spend more of our time dealing with the surprises that come with age and trying to spend as much precious time as we have left in the wind. Younger riders have been programmed by the government to accept the so called supreme authority of Uncle Sam. It's not uncommon to find as many as 5 generations that have traded freedom for social support. With all this in mind comes the next question. Does CMT/ABATE still have the same set of values as it was founded upon? Many members have expressed other issues as being more important than helmet legislation. The numbers of volunteers continues to drop at events, charter meeting attendance is down, and even some charters have gone away. At the lobby days this session we had a grand total of 10 members, including Wayne and myself, show up.

At our last skull session, over tea and coffee, (No alcohol! Times have sure changed) we came to a final question and a choice of direction. Does anybody really give a damn anymore? These are some of the most prophetic words to come out of this old man's mouth in a while or the greatest understatement of the year. Our group is becoming complacent and lethargic. (Humm, the previous comment may apply to this as well.) Do you want to continue chasing windmills and being judged by folks that don't know Cervantes from Cerveza? Don Quixote can continue on his quest or get back to being the voice of all Tennessee motorcyclists on the Hill. The choice is yours, we get real and get effective or we go away. By the way, all the years that Don Quixote spent on the road, he wore a helmet. So much for a romantic quest.

Don't let all this get you down, but take it to heart and make a positive change. We can make this a very effective political force in the state, if we are willing to make a few sacrifices and do a little work. Come to the Legislative Retreat on July 26 at Yog's place and stay for the Motorcycle Awareness Ride the next day. I hope we can start the legislative business by 2 and finish before supper time. Everyone is welcome.

Safety and Ed – Bus sign not ordered yet. Bob will follow up.


New Business – Gary made a motion that we donate \$300 to Buoy and Peggy to help with medical expenses. Lynn seconded the motion. The motion passed unanimously.




