Executive Board members should be at-Large to remove any suspicion of acting on behalf of their Local Charter – take back to Local Charter folks. Motion to table until December 2018 State Board meeting. Motion made by Scott Smith, seconded by Wendell Baldwin. Unanimous.

Presentation from the Corporate Treasurer – keep the free accidental death policy available to members? Motion by Lynne Greenwood, second by Scott Smith. Unanimous.

Presentation from the Chair – Lifetime memberships. Lifetime "joint" memberships? Continue to offer lifetime memberships? Motion not made – direction from the Chair to discuss inside Local Charters and present at December State Board meeting. Unanimous.

Presentation by MRF Liaison – upcoming Meeting of the Minds. Will be in Colorado this year and needs to be funded. Budget should be about \$600.00. Motion by Bette Stewart to ask Local Charters to pledge monies, second by Scott Smith. Unanimous. Contact Ed Domine at 931 744 9413.

Presentation by Activities Chair – 2019 New Year's Kickoff Party. Goal to make party room and guest rooms available at same price as 2018. Mark Waters and Carol Simpson. Event is suggested for Saturday 19, January 2019 with fall-back date of Saturday 26, January 2019. If anyone has a problem with the suggested date – speak to Mark Waters. Some CMT/ABATE, Incorporated members think that our work promoting the "don't ride fried" and "look twice, save a life" programmes are us doing what State employees are paid to do. Local Charters need to provide direction regarding "what" events, products, programmes they want to see occur. Suggestions so far; Bob Celmer - Memphis city bus signage. Lynne Greenwood – litterbags. Bob Celmer - tyre pressure gauges. Perhaps make mix of programme 25% (or less) "don't ride fried" and 75% (or more) motorcycle awareness. Send ideas to J. Robert Forbus – need before December 2018. Corporate Secretary is responsible for writing and negotiating Grant, and he may ask Carol Simpson for assistance. Additional discussion of PSA's and costs.
