
# **DIRECTORS COLUMN**

#### "YOUR RIGHTS -YOUR RIDE"



Another December 7th has passed and I notice every year it means less to folks in general. To me it will always be Pearl Harbor Day, the beginning of our countries greatest fight for freedom and liberty. The entire world bled for this. You may wonder what this has to do with helmet legislation and I would say everything. We ule an appointment with your aren't fighting to get rid of helmets, but for the freedom and liberty of choosing to wear one or not. All we have to give to our fight is a little time, but the price paid on December 7th, 1941 puts everything into proper perspective for me

A legislative retreat and strategy meeting was held on November 23rd. Every member, along with any other groups in the state had the opportunity to provide input. Based on that input, the representatives of CMT/ABATE membership decided on the following agenda for the 2014 session. We will continue the fight for helmet choice. Helmet reciprocity -if you are from a freedom of choice state, you do not have to wear a helmet in Tennessee AND it will be a secondary offense for those from Freedom of Choice stateswas number 2 on the list. This would encourage tourism and also provide some real numbers about riding without a helmet in this state. Third on the list was a bill that would state compliance of a vehicle and its occupants to safety and emissions regulations would be limited to those in place at the year of vehicle manufacture. In other words the state could not require catalytic convertors on your '36 knuckle or seat belts in your '57 vette.

texting, was a big one. This was actually the second most requested thing I received. It was decided to let those groups already working on this to do the job and offer our support. No need to muddy the waters. Cable barriers

are best handled through direct contact with TDOT. It wouldn't hurt to contact them with your personal opinions, but be respectful. Right of Way Violation has been dealt with legislatively and now the burden of educating your local law enforcement and judicial personnel is on your shoulders. Schedlocal judge, assistant DA and sheriff. Take a copy of the ROW law and the Ricky Otts Act. Explain it to them and leave the information along with contact information for vourself and CMT/ABATE. It doesn't get more "Grass Roots" than this.

There will be no single Lobby Day for 2014, but each charter will receive a day to come to the Hill and lobby. Charter names will be literally drawn from a hat and scheduled. This will give us a presence during the entire session and give you the opportunity take a personal part in our efforts. Keep in mind that you need to schedule meetings with your representative and your senator for your day to lobby. At the end of session we will schedule a Day on the Hill for Tennessee Motorcyclists. Everyone is welcome to come help at any time, but I would ask that you let me know ahead of time.

#### **DRAGON TALE**

At times we can be our own worst enemy. Over the past few months I have been contacted by individuals concerned with what they called "harassment of bikers" on US129 or Tail of the Dragon. There were claims that the THP and other law enforcement agencies were stopping motorcycles for such things as handle bar height and vertical tags along with accusations of misuse of funding. This resulted in letters and emails being sent to different state officials, including the governor. There is nothing wrong with taking action when something wrong has happened, but, the problem, in this case, is nothing did happen. These events did not occur in 2013. In fact, people should take time to research the facts before accusing someone of wrong doings and in the process causing damage to the reputation of CMT/ABATE Inc. We cannot afford this sort of damage to our credibility. Yes, over the years, the Governor's Highway Safety Office has given Blount County additional funds for High Visibility Enforcement Campaigns on Hwy 129. These funds were used to enforce safety laws on the Tail of the Dragon, particularly when there were event weekends" involving both Car and Motorcycle groups. There have been no "motorcycle only" checkpoints or profiling.

For those not familiar with these events, there was a website that contained the previously mention accusations. Readers were asked to send letters and emails to state officials and voice their complaints. The posting was from 2007, not 2013. The socalled victim, gave only a first name and no other information. Since 2010, thanks to a bill sponsored by Rep. John Deberry, vertical tags are now lawful. There are no handlebar height restrictions in Tennessee

since the late 80's. I know this might blow some minds, but you can't believe everything you read on the internet, especially when you don't read the details.

I would suggest if anything like this comes up in the future that you check the facts and contact someone that might have more information before you start writing the Governor. I appreciate those that did contact me over this before they reacted. My reason for taking so long to respond was due to the fact that I was taking time to research this rumor.

The THP does add troopers when they hear of an event on US129. It isn't about harassment, but is all about safety. I ride there every chance I get and know firsthand there isn't room in my lane for me and that on coming Miata. As long as you are obeying the law, you won't have a problem.

Here is Colonel Tracy Trott's official quote for this article (Col Trott is the head of Tennessee Highway Patrol): "Motorcycle only check points and profiling are prohibited by the Tennessee Constitution. The Department of Safety and Homeland Security does not engage in those types of law enforcement. We do, however, focus on several problem areas across the state where high volume and dangerous activity by all types of highway vehicles are a threat to the public safety."

#### CMT/ABATE, Inc. Legislative History What WE have Accomplished

#### ORGANIZATION

Founded in 1982 as Concerned Motorcyclists of Tennessee (CMT)

Refiled Corporation registration with Secretary of State in 1992 after merger with ABATE of Tennessee (East) and ABATE of the Mid-South (West) in 1991.

#### HELMET LAW BATTLES

Have continued to seek opportunities with elected officials, government agencies and departments, and the motoring public regarding freedom of choice in wearing helmets. It is not the device, but the law that is our point of concern. Senator Doug Henry has been our advocate for freedom of choice since the mid-1980's. He was instrumental in the education of the legislature that while seatbelts are a part of a four-wheel vehicle, and that device is warranted by the manufacturer to operate in a specific manner, helmets are not included in the sale of a motorcycle, have a disclaimer label in their lining stating they are NOT guaranteed or warranted to prevent injury, and are sold in the apparel department of motorcycle dealerships. We have gained some incremental legislative successes regarding helmet usage.

- Parade Bill- TCA 55-9-302 b4 18 years and older can ride in a parade without a helmet at speeds not to exceed 30 mph. Each incorporated community has its own parade ordinances as to whether a permit is required. No community as of this date has an ordinance to rescind the helmet choice provision of TCA 55-9-302 b4.
- Ventilated Helmet is Legal --TCA 55-9-302 a 2-4. Must have label stating approved by CPSC. Holes cannot exceed 1 <sup>1</sup>/<sub>2</sub>" in diameter. These helmets may be purchased in sports stores, department stores, specialty stores catering to roller blading, kayaking, bicycling, snowboarding, horseback riding, and other recreational activities involving some risk of crash or falling.
- Have repeatedly staged Freedom Rallies on the Capitol and annual Lobby Days within Legislative Plaza.

#### OTHER SUCCESSFUL LEGISLATIVE INITIATIVE INVOLVING MOTORCYCLING

- Repealed mandatory Crash Bar Law. **1984.** Formerly TCA 55-9-301
- Changed eye protection law from mandated windshields or goggles to allow clear or tinted glasses with impact resistant lens or face shields. **1984** TCA 55-9-304
- Established Legislation which created and funded the Tennessee Motorcycle Rider Education Program. Funded solely by \$2 from each motorcycle registration and \$1 of each M endorsement. **1987.** TCA 55-51-101-107
- Handicap Plate available on motorcycle 1988. Administrative decision involving TCA 55-21-101 et seq; DEFINITION OF MOTOR VEHICLE INCLUDES MOTORCYCLE in tca 55-1-103C). Landmark decision by legal department of legislature and general counsel of Department of Safety that the two above mentioned TCA sections equal a definition that a motorcycle is a "vehicle" and is to be considered as such in all laws referencing vehicles, including the DISABLED DRIVERS LAW OF 1975.

- Legalized continually flashing brake lights. TCA 55-0-402b. NOTE: this allowance is in conflict with federal law. Has not been challenged in court. Warning: Memphis does not, like most incorporated communities adopt the entire TCA into their city ordinances and refers to the Federal Statute in this instance.
- Convinced the Tennessee General Assembly to send a Joint Resolution to the US Congress in support of States Rights 1993
- Motorcyclists to treat electronic traffic signal that do not detect motorcycle as a 4-way (all-way) stop and proceed after a reasonable wait. **2003**. TCA 55-8-110(b)-
- Handlebar height of maximum height of 15 inches restriction lifted. Formerly TCA 55-9-305.Repealed in **2005** by Public Chapter 135.
- Military plates for motorcycles. Incorporated language for inclusion of motorcycles in original bill for all vehicle military plates which became law in 2005. TCA 55-4-110(b)
- Right of Way Violation legislation that increases fines and penalties for those who cause serious injury or death when violating right of way in an accident (applies to all vehicles)
   2006 and expanded in 2007
- Motorcycles specifically included in Lemon Law. **2010** TCA 55-24-101(4)
- Vertical Tags on motorcycles allowed. Letters read top to bottom. **2010** 55-4-110(b)
- Amended bad bill which would have prohibited motorcycle passengers under the age of 5 to a good bill—feet must be on passenger foot pegs and supported passage into law. **2012** Was HB 153, became TCA 55-8-164 e(1)
- The "Rickey Otts Act" which requires an officer to arrest drivers involved in accidents resulting in serious bodily injury or death when such drivers lack a valid driver license and evidence of financial responsibility; prohibits the issuance of a citation in lieu of arrest in such circumstances. **2012** Amends TCA title 39, Title 40, Title 55-10, title 55-12, title 55-50, and title 55-8
- Defeated HB 428/SB 253 which would have mandated Motorcycle Rider Education for those under 18. Our positionnot enough rider ed sites spread across the state to meet the demand, cost of travel and accommodates for youth prohibitive for successful enforcement (unfunded mandate) and infringes on parental rights for decisions of training and safety. 2013
- Have garnered many May is Motorcycle Awareness Month Proclamations and designations from several governors and the Tennessee General Assembly

#### CMT/ABATE will be amending a bill this that passed last year that will provide a specialty plate for Tennessee Motorcyclists.

The following is a letter to the CDC from Representative Tim Walberg (R) Michigan.

#### Dear Dr. Frieden:

I am writing to express my strong opposition to a series of findings and conclusions reached by the Centers for Disease Control and Prevention's (CDC) Community Preventive Services Task Force as part of their continued efforts to advocate in support of universal motorcycle helmet laws.

Of utmost concern is a slide contained in the recent October 23, 2013 presentation by the Helmet Law Review Team designated as the "Economic Impact of Motorcycle Helmet Law: A Systematic Review." Slide 11, entitled "Analytic Framework: Motorcycle Helmet Laws to reduce Motorcycle-related Fatal and non-Fatal Injuries," infers a positive awareness of helmet laws with the potential for reduced motorcycle use. The presentation goes on to conclude that "economic evidence shows that universal motorcycle helmet laws produce substantial economic benefits, and these benefits greatly exceed expected costs, "however, there is no reference whatsoever to the significant economic costs anticipated by reducing motorcycle use.

In fact, the only costs identified by the Task Force on slide 37 are the costs of purchasing a motorcycle helmet and the enactment and enforcement costs of helmet laws, which are concluded to be negligible. Not only does this contradict the earlier findings about how imposing motorcycle laws would discourage motorcycle use, but it ignores the positive economic impact motorcyclists provide.

Motorcyclists not only enjoy riding on American roads, they also spend billions of dollars touring and attending rallies. Reducing motorcycle use would have a detrimental effect on the motorcycle-industry, dealer sales, tourism, associated benefits of responsible and tax revenues. As an avid and experienced motorcycle rider, I believe government should be in the business of promoting the recreational, economic and environmental benefits or responsible motorcycle riding – not discouraging it.

The CDC has the great responsibility of addressing and protecting public health. During difficult fiscal times, the American people would be better served by your continued efforts to address widespread societal health matters such as virus prevention, cancer and heart disease. In order to ensure Congress and the public may be fully informed and confident in the information promulgated by the nation's health protection agency, I respectfully request that you provide answers to the following questions:

1. With the staff of the Community Preventive Services Task Force stating the "potential reduction of motorcycle use" as a potential outcome of helmet laws, is it the goal or strategy of the CDC to reduce the use of motorcycles - a legal mode of transportation - by recommending and pursuing a federal helmet law?

2. If so, how would the strategy be implemented and by what authority would it be instituted? Does the Community Preventive Services Task Force intend to engage Congress or the motorcycle community before making recommendations?

3. Do you believe CDC is the federal agency best suited to research and make recommendations on the issue of transportation safety?

4. As the CDC considers future policy recommendations, will you consider the full economic costs associated with

#### CDC TASK FORCE CALLS FOR HELMET LAWS

A task force operating under the auspices of the Atlanta-based Centers for Disease Control (CDC) is recommending that all states have a mandatory helmet law in place to require motorcycle riders of all ages to wear a helmet.

Citing reduced injuries and fatalities, as well as economic benefits, the Community Preventive Services Task Force, appointed by the director of the CDC, will make its recommendations to the federal agency and report its findings to the U.S. Congress in early December.

The CDC, whose primary mission is to fight disease, issued a report last summer recommending that all 50 states enact universal helmet laws in response to a sharp increase in motorcyclist fatalities; but ignoring the fact that the number of motorcycles in use nationwide has increased substantially over the past decade, and that costs associated with un-helmeted cyclists involved in fatal accidents represent a tiny fraction of overall U.S. healthcare expenditures.

In the meantime, U.S. Representative Tom Petri (R-WI) has authored a joint letter from members of Congress calling for the CDC to stop investigating motorcycling issues such as helmet laws, which they have no experience or expertise with, and "...to direct your attention and resources to areas that are not currently already being addressed elsewhere in the government."

Traditionally its "out with the old and in with the new" at the beginning of a new year, but 2014 finds the Motorcycle Riders Foundation (MRF), based in Washington, DC, still dealing the old. The three top ones are motorcycle only check points, E15 and the CDC.

Motorcycle only check points are unconstitutional in our state, but there are other objectives with this piece of legislation. It lays the ground work for a federal helmet law. Money is used to encourage helmet use. Amendments attached to federal bills tend to turn them into something more than they appear to be. Over the past few months MRF has asked everyone to contact their U.S. Congressmen on this.

The ethanol debate has turned into a regular free-for-all. The federal government, EPA, oil companies, members of the alternative fuel industry, automotive manufacturers and engineers along with farmers are all involved in this argument. The MRF was finally asked take part in this discussion. At least we now have an official voice in this fuel experiment by the federal government.

The CDC is by far the more serious of the three. This organization has become the administration's method of circumventing legislation. In other words, the President gets his way and We the people have no say. I don't consider myself a disease of epidemic proportions even though I ride a motorcycle and have guns, but the CDC says I am. Do you smoke, drink or are over weight? If

so, you are a disease, too. While we are wondering what the hell these fools are thinking, they are dead set on carrying out the anti -American agenda of this current administration. If you don't think this is real and can work, just look at what the EPA has done to the country. Neither the EPA nor the CDC have the authority to create law, but they are doing it with the encouragement of the President.


